SUBJECT: FY08 Proponent-Sponsored Engineer Corps Training Program (PROSPECT)
Procedural Information

1. This memorandum includes final information for the FY08 PROSPECT Program and contains guidance on required actions to make the process work effectively. The PROSPECT Program is based on customer training needs.
2. You will find PROSPECT Program information on the USACE Learning Center (ULC) website at <http://ulc.usace.army.mil>. Training coordinators may locate allocations based on instructions that were provided to them in the survey. Please note important course date and location change information in Enclosure 1, a list of course sessions that will accommodate extra students in Enclosure 2, and a list of cancelled courses and sessions in Enclosure 3.
3. The PROSPECT Program is entirely dependent on tuition income to keep the program viable. For that reason, like a commercial business, we must do an accurate job of forecasting training needs, and we depend on your responses to our training survey to plan our calendar. Knowing that planning a year in advance is difficult, we have built some flexibility into our program; however, the following policies and procedures apply:
 - a. Training coordinators and supervisors are vital to making our program a success. Upon receiving the allocated spaces, identify your students by name and provide credit card payment for each allocated space at least 60 days prior to class start date. Make payments by completing the Payment by Credit Card Form, Enclosure 4. The credit card payment form is also on-line at <http://ulc.usace.army.mil/Downloads/Credit Card Payment Form.doc>. Payment of PROSPECT tuitions using the IMPAC card is mandatory. If not paid when due (60 days prior to class start date), the space will become available for use by those on standby. Payments for standby students are due at the time of acceptance. NOTE: Do not include more students on a single payment form than your credit card limit will cover. Please submit additional payment forms as required.
 - b. Supervisors must ensure that each student nominee meets course prerequisites or submits a Request for Waiver along with the training request. The appropriate ULC Course Manager will review the Request for Waiver, coordinate with the course proponent, and provide a decision on the request within five working days of receipt.

c. Approximately 60 days prior to the start of each session of training, the ULC Registrars will provide Student Reporting Instructions.

d. A 60-day cancellation policy is effective for all approved allocations distributed to customer organizations. To avoid an adverse impact on both the ULC and the training program, please make every effort possible to use the spaces allocated to your organization. When that is not possible, the ULC must charge the full tuition for any spaces not cancelled 60 days prior to the start date of a course.

e. Training coordinators managing Intern training must also provide the name and organization for each Intern nominated to attend PROSPECT classes not later than 60 days prior to the start of training. Provide an approved Training Request Form (DD Form 1556, SF 182, or equivalent) at least 30 days prior to the start of training. You will find additional information in our Policy on Registration and Enrollment of Interns in Enclosure 5.

f. We have made every effort to accommodate your training needs in the sessions you requested; however, in certain courses, some sessions had many requests, generating a need for additional sessions. With other courses, where sessions did not fill, we had to cancel one or more sessions and move students to another remaining session. ***If these changes are unacceptable, please cancel the requirement immediately*** so that we may place a space-available student in the class.

g. If you need spaces in any class with vacancies, please submit a Request for Training, DD Form 1556 or SF 182, to the ULC Registrar's Office for enrollment (FAX: 256-895-7469).

4. We request that individuals with disabilities who require special services or accommodations contact Sue Frith at 256-895-7436; e-mail: Nellie.U.Frith@hnd01.usace.army.mil not later than 6 weeks prior to the course start date. She will coordinate the student's needs with the appropriate provider and respond with special instructions as needed.


